

ORDINANCE NO. 2993

AN ORDINANCE ESTABLISHING COMPENSATION  
FOR VARIOUS EMPLOYEES OF THE VILLAGE OF  
CRESTLINE, AND DECLARING AN EMERGENCY.

WHEREAS, it is the opinion of this Council that the compensation of Village employees should be established in a single Ordinance, and

WHEREAS, this Ordinance maintains the same rates as were paid in 2011.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Crestline, Ohio:

SECTION 1. That the compensation for members of the various departments be and the same is hereby established as follows:

That it is hereby determined that this Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that passage is necessary to continue authority to pay Village employees at their current rate in 2012, and shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.
