

ORDINANCE NO. 3181

ENTITLED AN ORDINANCE ACCEPTING THE ANNEXATION OF 2.004 ACRES OF LAND, MORE OR LESS; DIRECTLY ATTACHED TO THE VILLAGE OF CRESTLINE AND LOCATED GENERALLY SOUTH EAST OF THE EXISTING MUNICIPAL CORPORATION LIMITS ON MIDDLETOWN ROAD; AND SOUTH SIDE OF MIDDLETOWN ROAD IN JACKSON TOWNSHIP.

WHEREAS, a petition containing two property owner signatures for the annexation of 2.004 acres more or less of territory in Jackson Township, to the Village of Crestline, Ohio, was duly filed by Marc Milliron as Agent for said landowner on December 29, 2016; and

WHEREAS, the Crawford County Board of Commissioners accepts said petition on April 17, 2017 and therefore the Village of Crestline may accept this annexation after 60 days but no later than 120 days from the time that the Crawford County Board of Commissioners accepted such petition.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Crestline, Ohio:

Section 1: That the petition of 2.004 acres of land, more or less, for annexation of said land located in Jackson Township, Crawford County, Ohio, to the Village of Crestline, which land is generally south east of the existing municipal corporation limits on Middletown Road; and south side of Middletown road in Jackson Township is hereby accepted. A certified transcript of the proceedings for annexation and an accurate map of the territory, together with the Petition for Annexation and other papers relating to the proceedings of the Board

of Commissioners of Crawford County, Ohio are on file with the Clerk of Council of the Village of Crestline, and have been for more than sixty (60) days.

Section 2: That the Clerk be, and she is hereby, authorized and directed to make three (3) copies of this Ordinance to each of which shall be attached a copy of the map accompanying the Petition for Annexation, a copy of the transcript of the proceedings of the Board of Commissioners of Crawford County, Ohio relating thereto, and a Certificate of the correctness thereof. The Clerk shall then forthwith delivery one copy to the Crawford County Auditor, one copy to the Crawford County Recorder and one copy to the Secretary of State, and shall file notice of this annexation with the Crawford County Board of Elections within thirty (30) days after it becomes effective, and the Clerk shall do all other things required by law.

Section 3: That this Ordinance shall be in full force and effect from and after the earliest period allowed by law.
