

ORDINANCE NO. 3109

AN ORDINANCE AMENDING ORDINANCE 3090 KNOWN AS THE PERMANENT APPROPRIATION ORDINANCE FOR 2014 BY TRANSFERRING FUNDS WITHIN THE GENERAL FUND AND TO INCREASE APPROPRIATION IN THE STREET FUND, INCOME TAX FUND, SEWER FUND AND AMBULANCE FUND.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CRESTLINE, OHIO:

SECTION 1. THAT the Village General Fund: Police Account is decreased by \$12,545.00 as follows:

SECTION 3. THAT within the Income Tax Fund the sum of \$28,750.00 is hereby appropriated form un-appropriated reserves as follows:

SECTION 4. THAT within the Sewer Fund the sum of \$25,750.00 is hereby appropriated from un-appropriated reserves as follows:
