Resolution No. 16-41 – A RESOLUTION IN SUPPORT OF THE CRESTLINE HISTORICAL SOCIETY AS IT RELOCATES INTO A MORE PRACTICAL BUILDING, AND DECLARING AN EMERGENCY First reading held. Motion by Laferty, second by Moore for suspension of the rules for the second and third readings. Roll Call – Swartz, Laferty, Toy, Herold, Moore and Miley. Six (6) yeas. Motion by Laferty, second by Miley for adoption. Roll Call – Laferty, Toy, Herold, Moore, Miley and Moore. Six (6) yeas. Resolution No. 16-41 adopted.

Ordinance No. 3158 – AN ORDINANCE AMENDING CHAPTER 721 "WASTER COLLECTION" OF THE CRESTLINE CODIFIED ORDINANCES AND TO REPEAL ALL OTHER ORDINANCES CONTRARY THERETO. Mr. Laferty

makes a motion to refer back to legislation committee and hold to first readings. Second reading held.

Ordinance No. 3163 - VACATING A PORTION OF DEDICATED PUBLIC RIGHT OF WAY ALLEY RUNNING EAST AND WEST BEGINNING AT THE NORTH WILEY STREET AND RUNNING WEST TO AN ALLEY THAT RUNS NORTH AND SOUTH BETWEEN NORTH PEARL AND NORTH WILEY STREETS. Third reading held. Motion by Swartz, second by Herold for adoption. Toy and Laferty are both against the vacation of alley due to the lack of accessibility of emergency vehicles when needed. First reading held. Motion by Herold, second by Toy for suspension of the rules for the second and third readings. Roll Call – Swartz, Laferty, Toy, Herold, Moore and Miley. Six (6) yeas. Motion by Swartz, second by Moore for adoption. Roll Call – Herold, Moore, Miley, Swartz, Laferty and Toy. Six (6) yeas. Ordinance No. 3166 adopted.

Ordinance No. 3167 – AN ORDINANCE PROVIDING FOR LEGAL COUNSEL FOR THE VILLAGE OF CRESTLINE FOR THE YEAR 2017, AND DECLARING AN EMERGENCY. First reading held. Motion by Swartz, second by Laferty for suspension of the rules for the second and third readings. Roll Call – Swartz, Laferty, Toy, Herold, Moore and Miley. Six (6) yeas. Motion by Herold, second by Moore for adoption. Roll Call – Moore, Miley, Swartz, Laferty, Toy and Herold. Six (6) yeas. Ordinance No. 3167 adopted.

Ordinance No. 3168 – TO PERFORM A MICROSURFACING PROJECT ON STATE ROUTE 598 THROUGH THE VILLAGE OF CRESTLINE IN CRAWFORD COUNTY. First reading held. Motion by Herold, second by Swartz for suspension of the rules for the second and third readings. Roll Call – Swartz, Laferty, Toy, Herold, Moore and Miley. Six (6) yeas. Motion by Moore, second by Miley for adoption. Roll Call – Miley, Swartz, Laferty, Toy, Herold and Moore. Six (6) yeas. Ordinance No. 3168 adopted.

Ordinance No. 3169 – AN ORDINANCE PROVIDING FOR COURT MAGISTRATE FOR THE VILLAGE OF CRESTLINE FOR THE YEAR 2017, AND TO REPEAL ALL OTHER ORDINANCES CONTRARY THERETO AND DECLARING AN EMERGENCY. First reading held. Motion by Herold, second by Laferty for suspension of the rules for the second and third readings. Roll Call – Swartz (yea), Laferty (yea), Toy (nay), Herold (yea), Moore (yea) and Miley (yea). Motion by Miley, second by Swartz for adoption. Mr. Toy asked Mr. Burton if this requires council approval. Mr. Burton stated that historically it has. Mr. Toy asked what happened with

Amy Skroptis. Mayor McDonald explains to council the reason for a new appointment to position. Roll Call – Swartz (yea), Laferty (yea), Toy (nay), Herold (yea), Moore (yea) and Miley (yea). Ordinance No. 3169 adopted.

Ordinance No. 3170 – AN ORDINANCE INCREASING COMPENSATION FOR VARIOUS EMPLOYEES OF THE VILLAGE OF CRESTLINE AND DECLARNG AN EMERGENCY. First reading held. Motion for suspension of the rules for the second and third reading. Roll call – Swartz, Laferty, Toy, Herold, Moore and Miley. Six (6) yeas. Motion by Herold, second by Swartz for adoption. Roll call – Laferty, Toy, Herold, Moore, Miley and Swartz. Ordinance No. 3170 adopted.

Old Business - None

New Business – Mr. Herold reported on a planning commission meeting held on December 15th as follows; 1) Dave Sharrock turned in resignation – starting new job; 2) Purpose of meeting was rezoning of property owned by Rod Mosier from light industrial to heavy industrial. Request was approved with the condition that the company complies with salvage yard regulations by June, 2017. A public hearing will be scheduled for February 6th, 2017 @ 6:45 p.m.

Mr. Herold also announced that this would be his last year to chair Harvest Festival.

Disc Golf Course received a donation of 10,000 pounds of lumber from Cedar Point.

Mr. Laferty received email from Dave Sharrock resigning from Tree Commission. Mr. Laferty asked Mayor McDonald to appoint Mark Schneider to replace Mr. Sharrock.

Mr. Laferty scheduled an Ad Hoc committee meeting on January 9th @ 7:00 p.m. to continue discussion.

Mr. Swartz asked about upcoming meeting dates that fall on government holidays. Majority of council agreed to keep meeting dates as is.
