The following is an Ordinance enacted by the Village of Crestline of Crawford County, Ohio,  
(Ordinance/Resolution) (Local Public Agency)

**SECTION I – Project Description**

WHEREAS, the LPA has determined the need for the described project:

*Bridge Inspection Program Services, including, but not limited to, bridge load rating calculations, scour assessments, bridge inspections, and fracture critical plan development.*

NOW THEREFORE, be it ordained by the Council of Village of Crestline, Crawford County, Ohio.

**SECTION II – Consent Statement**

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

**SECTION III – Cooperation Statement**

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

*The State shall assume and bear 100% of all of the cost for Bridge Inspection Program Services requested by the Village and agreed to by the State. Eligible Bridge Inspection Services are described in the Consultant's Scope of Services Task Order Contract (Exhibit A).*

*The LPA agrees to pay 100% of the cost of those features which are not included in Exhibit A.*

**SECTION IV – Utilities and Right-of-Way Statement**

The LPA agrees that all right-of-way required for the described project will be made available in accordance with current State and Federal regulations.

**SECTION V – Authority to Sign**

Marc Milliron, Village Administrator of said Village of Crestline, is hereby empowered on behalf of the  
(Contractual Agent) (LPA)  
Village of Crestline to enter into contracts with the Director of Transportation which are necessary to
