

ORDINANCE NO. 3102

AN ORDINANCE TO AMEND CHAPTER 1501 OF THE CODIFIED ORDINANCES OF CRESTLINE TO REPLACE ALL REFERENCES TO BOCA BASIC FIRE PREVENTION CODE, 1984 WITH THE 2011 OHIO FIRE CODE, AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CRESTLINE, OHIO:

SECTION 1. That Chapter 1501 of the Codified Ordinances of Crestline is amended in its entirety and shall read as follows:

**CHAPTER 1501  
2011 OHIO FIRE CODE**

**1501.01 ADOPTION.**

The 2011 Ohio Fire Code is incorporated herein as fully as if set out at length.

**1501.02 PURPOSE.**

The purpose of the 2011 Ohio Fire Code as adopted herein is to prescribe minimum standards and regulations governing conditions hazardous to life and property from fire or explosion.

**1501.03 APPLICATION.**

The 2011 Ohio Fire Code as adopted herein applies to the use of all lands and properties within the Municipality and such other lands or properties owned by the Municipality which are situated outside the corporate limits thereof.

**1501.04 COPIES.**

Copies of Codes as adopted in this chapter are on file with the Clerk of Council for inspection by the public and also on file in the County Law Library, and the Clerk has copies available for distribution to the public at cost.

**1501.05 CONFLICT.**

In case of conflict between the 2011 Ohio Fire Code and any other Municipal ordinance or technical code adopted thereby, the more restrictive provision shall govern.

**1501.99 PENALTY.**

(a) Whoever violates any provision of the 2011 Ohio Fire Code as adopted by this chapter or fails to obey an order issued thereunder shall be guilty of a misdemeanor of the first degree. Each day on which an offense occurs or continues shall be deemed a separated offense.

(b) Nothing in subsection (a) hereof shall prevent the Municipality from pursuing any civil remedies open to it.

SECTION 2. That the original Chapter 1501 is repealed.

SECTION 3. That it is hereby determined that this Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that there is an immediate need to update all references to the current Fire Code, and this Ordinance shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members' elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.
