SECTION I - Project Description

WHEREAS, the State has identified the need for the described project:

The purpose of this project is to perform a smooth seal pavement treatment on MED SR 94, HUR SR 18, RIC SR 61, and on CRA SR 61 within the corporation limits of Crestline.

Approximately 1.67 miles of work on SR 61 for this project is within the Village.

This project is currently scheduled for the summer 2016 construction season.

NOW THEREFORE, be it ordained by the Village of Crestline of Crawford County, Ohio.

SECTION II - Consent Statement

Being in the public interest, the Village gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The Village shall cooperate with the Director of Transportation in the above described project as follows:

- 1) *The Village gives consent for the above improvement,*
- 2) *No funds are required from the Village except that the Village agrees to assume and bear one hundred percent (100%) of the total cost for added construction items requested by the Village and not necessary for the improvement as determined by the State and the Federal Highway Administration.*

SECTION IV - Maintenance

The Village will maintain the right-of-way and keep it free of obstructions, and hold said right-of-way inviolate for public highway purposes.

SECTION V - Authority to Sign

necessary to complete the above described project.
