

ORDINANCE NO. 3194

AN ORDINANCE AWARDING A CONTRACT TO SHARPNACK CHEVROLET BUICK CADILLAC OF WILLARD OHIO, FOR THE PURCHASE OF TWO CHEVY PICKUP TRUCKS FOR THE VILLAGE SERVICE DEPARTMENT FOR THE SUM OF \$64,769.06 THROUGH THE STATE OF OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES COOPERATIVE PURCHASING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, this Village participates in the State of Ohio Department of Administrative Services Cooperative Purchasing Program authorized by R.C. 125.04 which allows this Village to purchase equipment at state bid prices without the necessity of the Village seeking competitive bids, and

WHEREAS, utility vehicles for the Service Department which meet the requirements of this Village are available through this program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CRESTLINE, OHIO:

SECTION 1. THAT a contract is hereby awarded to Sharpnack Chevrolet Buick Cadillac of Willard Ohio, for the purchase of a 2017 Chevy Silverado 2500HD 2WD regular cab half ton with Utility bed under State Bid Contract for the Village Service Department for the total sum of Thirty-One Thousand Five hundred eighty-five and 50/100 dollars (\$31,585.50) through the State of Ohio Department of Administrative Services Cooperative Purchasing Program.

SECTION 2. THAT included with this contract awarded to Sharpnack Chevrolet Buick Cadillac of Willard Ohio, the purchase of a 2018 Chevy Silverado 2500HD 4WD regular cab three-quarter ton with plow package under State Bid Contract for the Village Service Department for the total sum of Thirty-Three Thousand One hundred eighty-three and 56/100 dollars (\$33,183.56)

through the State of Ohio Department of Administrative Services Cooperative Purchasing Program.

SECTION 3. THAT the Village Administrator of the Village of Crestline shall contract with Sharpnack Chevrolet Buick Cadillac of Willard Ohio.

SECTION 4. THAT it is hereby determined that this Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that the acquisition of this vehicle as soon as possible is necessary so that the level of equipment can be maintained, and this Ordinance shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.
