

ORDINANCE NO. 3197

AN ORDINANCE TO AMEND SECTIONS III AND VI OF ORDINANCE NO. 2703 AMENDING THE HARVEST FESTIVAL DIRECTOR AND ACCOUNTING PROVISIONS, AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 2703 has not been updated since 1998, and

WHEREAS, certain amendments would improve the operation of the Crestline Harvest Festival for the betterment of the community.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CRESTLINE, OHIO:

SECTION 1. That Section III of Ordinance No. 2703 is amended and shall read as follows:

Section III.

- (a) The Crestline Harvest Festival Director shall be appointed by the Mayor for a term of three (3) calendar years, and shall serve without compensation.
- (b) The Director may appoint up to ten (10) persons to serve on the Harvest Festival Committee. Committee members shall serve under the direction of the Director without compensation. All Committee appointments shall require Council confirmation.
- (c) Only the Director is authorized to solicit private support and contributions for the annual operation of the Festival. All contributions shall be reported in writing and deposited with the Village Fiscal Officer.

- (d) The Committee is authorized to prepare and execute by the Director the necessary contracts and agreements with vendors, merchants, concessionaires, and other necessary parties upon review and approval of the Village Law Director.

SECTION 2. That Section VI of Ordinance No. 2703 is amended and shall read as follows:

Section VI.

- (a) There is hereby established the "Crestline Harvest Festival Account" in the General Fund. All revenues and expenses arising from the operation of the Harvest Festival shall be deposited in, and appropriated from, such account, and such monies shall be under the control of the Village Fiscal Officer.
- (b) All payments to or for the benefit of the Harvest Festival shall be either to the Village of Crestline, Ohio or the Crestline Harvest Festival.
- (c) The Village Fiscal Officer shall annually provide a written report to the Mayor, Village Administrator, and Council of the annual revenues and expenditures for each completed Harvest Festival.
- (d) Each year Council shall appropriate an amount of funding that shall be available to the Committee for its annual expenditure to operate and promote the Harvest Festival. It shall be the Committee's responsibility to operate and promote the Festival within the annual budget set by Council.

SECTION 3. That the original Sections III and VI of Ordinance No. 2703 are repealed.

SECTION 4. That it is hereby determined that this Ordinance is an emergency measure necessary for the preservation of the public peace, health, safety and welfare of the residents of this Village and for the further reason that there is an immediate need to adopt and implement these amendments prior to the commencement of the planning of the 2018 Festival events, and this Ordinance shall therefore go into immediate effect provided it receives a two-thirds (2/3) vote of all members elected to this Council, otherwise it shall go into effect in thirty (30) days if passed by a majority vote of Council.
